



This document provides an **overview of services/care categories** for which prior authorization may be required for **some commercial, non-HMO Blue Cross and Blue Shield of Illinois (BCBSIL) members. Always check eligibility and benefits first** via the [Availity® Provider Portal](#) before rendering services to determine prior authorization requirements and utilization management vendor information, if applicable.

The following services may require prior authorization based on the member's benefit plan:

<p>Behavioral Health and Chemical Dependency Facility Admissions (Request prior authorization through BCBSIL)*</p> <ul style="list-style-type: none"> • Inpatient • Partial Hospitalization • Residential Treatment Center (RTC) <p>Behavioral Health and Chemical Dependency Services Outpatient (through BCBSIL)</p> <ul style="list-style-type: none"> • Applied Behavioral Analysis (ABA)** • Electroconvulsive Therapy** • Intensive Outpatient Treatment* • Psychological Testing/Neuropsychological Testing** • Repetitive Transcranial Magnetic Stimulation** <p><i>*Code list not available.</i> <i>**Refer to the Commercial Outpatient Behavioral Health Prior Authorization Code List for codes that may require prior authorization.</i></p>	<p>Specialty Pharmacy Medications (Medications Covered Under the Member's Medical Benefits)**</p> <ul style="list-style-type: none"> • Infusion Site of Care – Medical necessity review is required for therapy and for place of infusion (BCBSIL) • Provider Administered Drug Therapies – Medical necessity review is required for therapy only (BCBSIL) • Medical Oncology and Supportive Care– Medical necessity review (through AIM) is required for oncology drugs that are supported by an oncology diagnosis. <p><i>**Refer to the Specialty Pharmacy Drug List for prior authorization requirements.</i></p>
<p>Pharmacy Benefits (Prescription Drugs Under the Member's Pharmacy Benefits)</p> <ul style="list-style-type: none"> • Prime Therapeutics (Prime) is our pharmacy benefit manager for BCBSIL members with prescription drug coverage. For some medications under the member's pharmacy benefit, prior authorization through Prime is required before the drug will be covered. <p><i>**Refer to our https://www.bcsil.com/provider/pharmacy/pa_st_programs.html to identify drugs that may require prior authorization through Prime</i></p>	<p>Note: For some members, pre-notification, rather than prior authorization may be required for some advanced imaging services. This may involve obtaining a Radiology Quality Initiative (RQI) number through AIM.</p> <p><i>When you check eligibility and benefits, you'll be advised if pre-notification is required, and utilization managements vendors that must be used, if applicable.</i></p>
<p>Exceptions and Reminders:</p> <ul style="list-style-type: none"> • This information does not apply to HMO members. • For Federal Employee Program® (FEP®) members, check eligibility and benefits by calling 800-972-8382. For FEP members, you must call the local Blue Plan where services are being rendered for prior authorization, regardless of the state in which the member is insured. • For out-of-area (BlueCard®) members, call the BlueCard Eligibility® Line at 800-676-2583 to check eligibility and benefits. For prior authorization information, use the online router tool to go to the member's Home Plan website. 	

Please note that checking eligibility and/or benefits or the fact that prior authorization or pre-notification has been obtained or an RQI number has been issued is not a guarantee of payment. Benefits will be determined on a claim is received and will be based upon, among other things, the member's eligibility and the terms of the member's certificate of coverage, including, but not limited to, exclusions and limitations applicable on the date services were rendered. Certain employer groups may require prior authorization for imaging services from other vendors. If you have any questions, call the number on the member's ID card.
